

**Supplementary Information Notice on the Processing of Personal Data  
pursuant to Article 13 of Regulation (EU) 2016/679 (“GDPR”)**

*This notice is provided for the processing of data necessary for the management of ancillary services related to the “IX International Conference On Computational Bioengineering” to which you are registered, and should be considered as an addition to the privacy notice regarding the processing of personal data provided for the registration and participation in courses promoted and organized by UCBM Academy of the Università Campus Bio-Medico di Roma. For all information not expressly included below, please refer to that notice pursuant to Article 13 of the GDPR.*

**1. Data Controller and Data Protection Officer**

We inform you that, pursuant to Article 13 of the GDPR, your personal data will be processed by **Università Campus Bio-Medico di Roma**, located in Rome (RM), Via Álvaro del Portillo n. 21, Tax Code 97087620585, as the Data Controller (hereinafter, the “**Controller**” or “**UCBM**”).

**2. Categories and Types of Personal Data Processed**

The personal data processed fall under the category of common data and include, in particular, your personal and identification details (e.g., your first name and last name), and contact information (your email address), information regarding accommodation and transfer services. On the occasion of your participation in the ICCB conference promoted by UCBM Academy, subject to your explicit and specific consent, personal data belonging to special categories pursuant to Article 9 of the GDPR may be collected—such as information regarding your food intolerances and/or allergies—in order to ensure proper management of catering and/or food services during the conference.

**3. Purpose of Processing and Legal Basis**

Personal data will be collected through a dedicated form prepared by UCBM and processed for purposes related to the management of ancillary services connected to the ICCB conference, specifically for the organization and logistical coordination of transfer, accommodation, and catering services.

As part of these activities, information regarding any food intolerances and/or allergies that you may communicate may also be processed, in order to ensure proper access to services and to safeguard your safety and health during participation in the conference and related events.

The legal basis for the processing of personal data for the purposes indicated above is, for general data, Article 6(1)(b) of the GDPR, and for data belonging to special categories—specifically health-related data—Article 9(2)(a) of the GDPR, i.e., your specific consent. You may withdraw your consent pursuant to Article 7 of the GDPR at any time without affecting the lawfulness of the processing based on consent given before its withdrawal.

The provision of personal data for the above-mentioned purpose is optional; however, if you choose not to provide such data, the Data Controller will not be able to collect information regarding any food intolerances and/or allergies, nor ensure the proper organization of catering services. As a result, it will not be possible to implement the necessary measures to safeguard your safety and health during your participation in the conference.

Once provided, your personal data may also be processed to fulfill legal obligations, pursuant to Article 6, paragraph 1, letter c) of the Regulation. Furthermore, should it become necessary to establish, exercise, or defend a legal claim, your data may be processed for the legitimate interest pursued by the Controller, identified on the basis of a balancing of interests, pursuant to Article 6, paragraph 1, letter f) and Article 9, paragraph 2, letter f) of the Regulation.

**4. Recipients of Personal Data**

Your personal data may be shared, for the purposes mentioned above, with individuals authorized by the Controller to process personal data pursuant to Articles 29 and 32 of the Regulation and Article 2-*quaterdecies* of the Legislative Decree 196/2003 (so-called “Privacy Code”); with entities typically acting as data processors pursuant to Article 28 of the Regulation on behalf of the Controller; and with entities, bodies, or authorities to whom communication is mandatory under legal provisions or orders from public authorities.

**5. Transfer of Data to a Third Country or International Organization**

With regard to any future transfer of your personal data to non-EU countries outside the European Economic Area (EEA) or to international organizations, the Controller informs you that such processing, if it occurs, will be carried out in compliance with applicable regulations and in accordance with one of the legal mechanisms permitted under Articles 44–49 of the Regulation. These may include, for example, your explicit consent, the adoption of Standard Contractual Clauses approved by the European Commission, or the selection of entities adhering to international data transfer frameworks, in line with the European Data Protection Board’s Recommendations 01/2020.

**6. Retention Period of Personal Data**

Your data will be processed and stored for the time necessary to achieve the above-mentioned purpose, in compliance with the principles of data minimization and storage limitation, and in any case no longer than the duration of the service provision. Data belonging to special categories, pursuant to Article 9 of the GDPR, will be processed and stored until any withdrawal of the consent given. The Controller reserves the right to retain the data for the time necessary to comply with legal obligations to which it is subject, as well as to establish, exercise, or defend a right in out-of-court or judicial proceedings.
